IMMIGRATION LAWS:

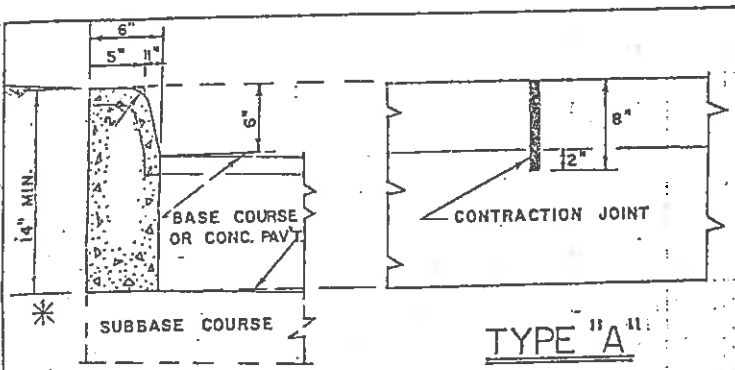

All work shall be in full compliance with current ADA standards.

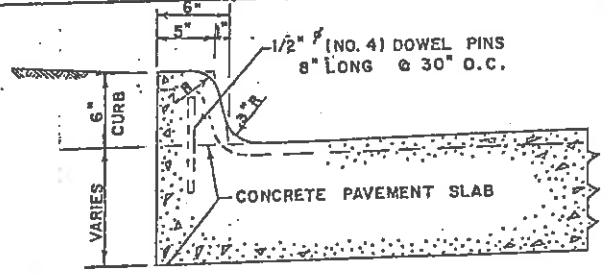

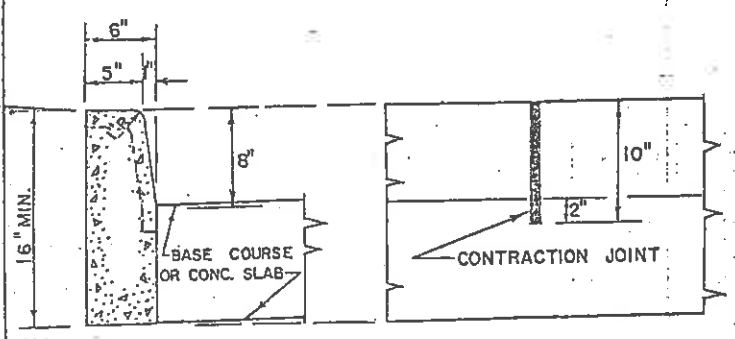
TYPE "A"

DETAIL OF CONCRETE HEADER CURB



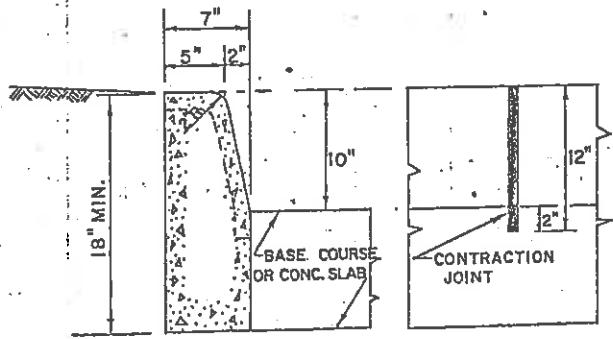

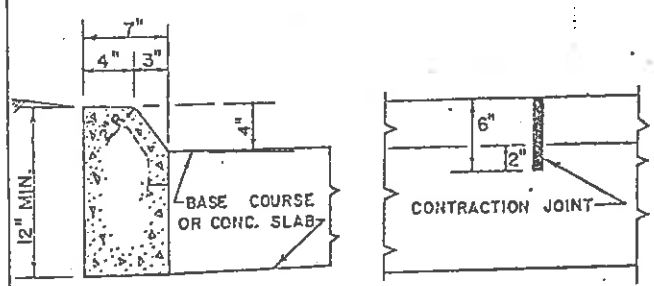

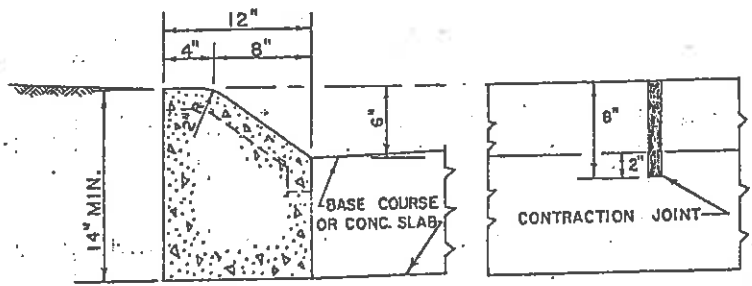

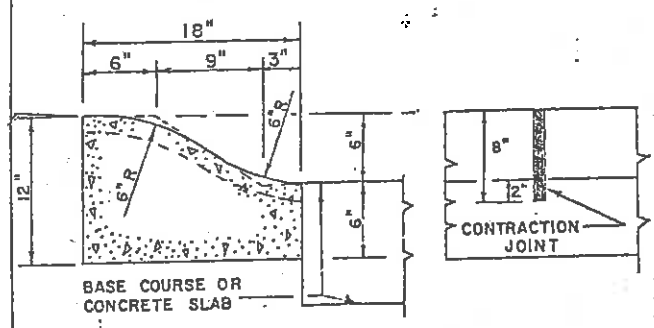

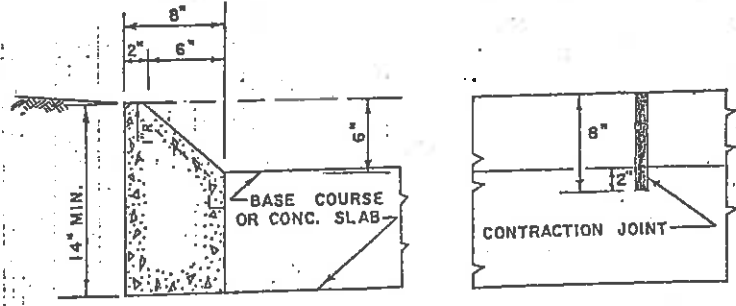
